Your contribution can help foster children and others who need our help right here in Arizona. By reducing the amount you owe the state, you can improve lives and know you made a difference.

Any donation you make to Catholic Charities may qualify for the Foster Care Charitable Tax Credit up to \$500 for single filers and \$1,000 for joint filers. A tax credit reduces your tax liability, and is different than a deduction.

HERE'S HOW IT WORKS:

Bill and Sharon earned \$65,000 this year. They made a gift of \$1,000 to Catholic Charities for the Foster Care Charitable Tax Credit. Their Arizona tax liability based on \$65,000 in earnings is \$2,184. As joint filers, they can take a credit of \$1,000 against their tax liability for their gift to Catholic Charities, dropping their liability to \$1,184.

\$2,184 Bill and Sharon's tax liability

- **\$1,000 maximum tax credit for joint filers**

- = **\$1,184 AZ state tax liability and a warm feeling in their hearts**

TAX CREDIT FAQs

What is the Foster Care Charitable Tax Credit?

It's a dollar-for-dollar income tax credit available for contributions made to qualifying organizations, including Catholic Charities Community Services.

Why Catholic Charities?

Since 1933, Catholic Charities has provided foster care services. We help the most vulnerable throughout northern and central Arizona—regardless of race, religious affiliation, ethnicity or economic status—with permanent solutions that improve lives. Last year we helped more than 20,000 individuals with programs and services in seven counties to:

- Protect and nurture children
- Strengthen and reunify families
- Welcome and assist refugees
- Shelter the homeless and abused
- Aid those in crisis
- Help the impoverished.

How much credit can I receive?

Up to \$500 for single filers and \$1,000 for joint filers

What's the deadline to take advantage of the tax credit?

Contributions must be made by the April tax deadline.

How do I claim the credit after I make the contribution?

When you file your taxes, just include AZDOR Form 352. Use QFCO Code: 10000

Can I take advantage of other tax credits (stacking)?

Yes, there are numerous types of tax credits. The Foster Care Charitable Giving Tax Credit is one type. There is a different AZDOR form required for each type of tax credit and different limits for each category. Check with your tax advisor for specific limits and available credits.
